



## Foster Home/Care Contract

I, \_\_\_\_\_ (“Foster Home” or “Foster Family”), do hereby enter into this contract with **Meant 2B Loved Pet Rescue Society** of my/our own free will and agree to give the foster care and shelter to rescued pet(s) (“Foster Pet”) from time to time as agreed to between the Foster Home and Meant 2B Loved Pet Rescue Society.

The Foster Family acknowledges and understands that Meant 2B Loved Pet Rescue Society does not have complete prior knowledge of the Foster Pets health and temperament. The Foster Family will take all necessary precautions to protect myself/ourselves and others who might come into contact with the Foster Pet, including privately owned pets.

Initial \_\_\_\_\_

The Foster Family understands and agrees that Meant 2B Loved Pet Rescue Society will not be held responsible for any injury, illness or disease contracted by any animals privately owned, or for property damage or harm to other pets, persons or property, both moveable and immovable, that may come into contact with the Foster Pet while it is in the Foster Family’s care. In that regard, I hereby release, discharge, and agree to indemnify and save Meant 2B Loved Pet Rescue Society, its directors, officers, volunteers, coordinators and representatives from any and all claims, damages, losses, expenses, actions and causes of action, including legal fees on a solicitor/client basis, arising out of any act or occurrence on account of my/our care, control and possession of the Foster Pet. In addition to any other types of damage, this clause specifically releases Meant 2B Loved Pet Rescue Society from any

liability for injuries, illness or damage to persons or property, including bites, scratches, and diseases, and of which shall, at the sole and absolute discretion of Meant 2B Loved Pet Rescue Society be determined as either directly or indirectly resulting from my/our actions, neglect or breach of my/our duties as the Foster Family. The Foster Family agrees that the Foster Pet shall not be removed from the address listed below or disposed of without prior written agreement of Meant 2B Loved Pet Rescue Society. The Foster Family will return the Foster Pet immediately to Meant 2B Loved Pet Rescue Society should any problem or circumstance arise where the Foster Family is no longer willing or able to care for the Foster Pet in the Foster Home in the manner which Meant 2B Loved Pet Rescue Society expects from the Foster Home. The Foster Family agrees and understands that Meant 2B Loved Pet Rescue Society shall be responsible for the payment of all necessary veterinary care of the Foster Pet while the Foster Pet is in the Foster Home. Any veterinary visit must have prior approval from a Meant 2B Loved Pet Rescue Society core member with the exception of emergency care; such emergency care will require a phone call to a Meant 2B Loved Pet Rescue Society core member as soon as reasonable possible. The Foster Family will not be reimbursed for any unapproved expenses or expenses as a result of negligence other than emergency care, incurred in the normal daily care of the Foster Pet. The Foster Family understands and agrees that the Foster Pet must be spayed or neutered as quickly as possible, if not done prior to being placed in the Foster Home. Initial \_\_\_\_\_

The Foster Family is fully aware that under no circumstances shall the Foster Pet be bred or be allowed to breed and will take all necessary precautions to prevent this from happening. Initial \_\_\_\_\_

The Foster Family agrees to keep the Foster Pet in safe, sanitary and healthy living conditions; will provide the proper food, water, exercise, love and attention, and will help the Foster Pet overcome any fears or aggressiveness that causes unacceptable behavior. **The foster Family agrees that no prong collars, shock collars, and/or choke chains are to be used at any time on a Foster Pet.** Initial \_\_\_\_\_

The Foster Family agrees that the Foster Pet shall become a household companion and will not be an outside pet or left outside unattended for any length of time. Initial \_\_\_\_\_

The Foster Family agrees to immediately notify Meant 2B Loved Pet Rescue Society of any change in the status of either the Foster Pet in his/her care or the Foster Home environment and to immediately notify a Meant 2B Loved Pet Rescue Society representative in the event the Foster Pet is injured or Missing. Initial \_\_\_\_\_

The Foster Family agrees to inform Meant 2B Loved Pet Rescue Society if the Foster Pet will be travelling on trips and vacations and will provide complete and proper contact information as to where they may be contacted while travelling with the Foster Pet. The Foster Family understands that under no circumstances will Meant 2B Loved Pet Rescue Society pay for boarding or kenneling fees.

Initial \_\_\_\_\_

The Foster Family agrees that a Foster Pet will not ride in the back of a pickup truck under any circumstances, including those such as in a cage/kennel, or tied and that the Foster Pet shall not remain in any vehicle in extreme heat or cold or with the windows down, or unattended for any amount of time.

Initial \_\_\_\_\_

The Foster Family understands that Meant 2B Loved Pet Rescue Society is a volunteer organization that does not pay Foster Homes for their time or services in any way, but will assist in providing food, toys, crates/cages, and training accessories for the Foster Pet.

Initial \_\_\_\_\_

The Foster Pet will remain the property of Meant 2B Loved Pet Rescue Society until an adoption has been finalized. The Foster Family will, upon request, immediately release the Foster Pet to a representative of Meant 2B Loved Pet Rescue Society. Failure to comply will result in enforcement by local law enforcement.

Initial \_\_\_\_\_

The Foster Family understands they have no authority to place or promise the Foster Pet in care to any home without written approval from a core member of Meant 2B Loved Pet Rescue Society. This includes returning the Foster Pet to its prior owner.

Initial \_\_\_\_\_

The Foster Family agrees to be courteous, helpful, and honest to potential adopters and to cooperate in showing the Foster Pet and accommodating potential adopters who wish to see the Foster Pet. The Foster Family will regularly provide Meant 2B Loved Pet Rescue Society with a fair and honest assessment of the Foster Pet, as to medical status and behavior. Foster Family will regularly keep open communication with Meant 2B Loved Pet Rescue Society and regularly check their email/messages and reply promptly.

Initial \_\_\_\_\_

In the event of abuse or injury to the Foster Pet or in the case of a breach of this contract, the Foster Pet must be returned immediately, including all food, training accessories, toys, paperwork, medical records, and other material that has been provided with the Foster Pet, to Meant 2B Loved Pet Rescue Society at the Foster Family's sole expense. Failure to comply will result in enforcement by local law enforcement.

Initial \_\_\_\_\_

The Foster Family enters into this contract with Meant 2B Loved Pet Rescue Society with the full knowledge they will be responsible for the safety and well-being of the Foster Pet while it is in foster care.

Initial \_\_\_\_\_

This contract shall be construed and interpreted in accordance with the laws in force in the Province of British Columbia, or the province of residence for the Foster provider.

Initial \_\_\_\_\_

This Agreement may be executed in separate counterparts and with electronic signature with the same effect as if all Parties had executed the same document. All such executed counterparts together shall constitute one agreement.
